



**Week # 3 9/17/05**

1. B16 is returning Team A's punt when he fumbles at the Team B 40-yard line and the ball rolls out of bounds at the 43-yard line. Ruling:
2. Substitute A80 joins Team A players who are assembled near the neutral zone. QB A9 is shouting instructions. After six seconds, the Team A players move to their positions and replaced player A85 runs to the Team A team area. Ruling:
3. Fourth-and-goal at the five-yard line. Runner A22 runs toward the sideline and becomes airborne as he crosses the goal line pylon. Ruling:
4. Third and goal at the three-yard line with six seconds remaining in the half. QB A9 catches the snap and immediately throws the ball forward hitting the leg of guard A63. The ball falls incomplete. Ruling:
5. Second and 10 at the Team B 40-yard line, A80 intentionally runs out-of-bounds and is then airborne as he receives a forward pass. The catch is completed inbounds at the 25-yard line. A80 fumbles at the 20-yard line and B19 recovers and is downed at the 17-yard line. Ruling:
6. Fourth-and-seven at the Team A 30-yard line. Team A is in scrimmage kick formation with A3 positioned 15 yards behind the snapper. A3 throws the ball high and 40 yards beyond the neutral zone. As potential receiver A87 attempts to catch the ball, B14 pushes him away from the ball and the pass is incomplete. Ruling:
7. Fourth and 10 at Team B's 20-yard line. The period ends during a play when Team A throws an incomplete illegal forward pass at the 16-yard line. Ruling:
8. Team A is encroaching during its free kick and the ball, previously untouched, has gone more than 10 yards. It is recovered by B37 who is on his knees at the time of recovery. Ruling:
9. The head coach alerts the linesman that he is requesting a head coach's conference with the referee. Ruling:
10. The ball is ready for play on a kickoff and Team B, after several warnings is slow to place players in position. Ruling:
11. 3rd and 5 from the B22, B45 intercepts the ball at the B4 yard line and runs to the B6 yard line where he is hit and the ball pops out. The loose ball is muffed by B10 and goes in and out of the end zone. Ruling:

12. 3rd and 12 from the A4 yard line B27 intercepts a pass from A8 at the A19 yard line and returns the ball back to the A5 yard line where he is hit and fumbles the ball, tackle A77 recovers the ball off the bounce at the A2 yard line and his momentum carries him into the end zone where he is tackled by B90. Ruling:
13. 4th and 15 at the 50, A8 punts the ball high into the air, the ball bounces high off the turf at the B30, receiver B85 runs up and signals for a fair catch at the B30 after the ball hits the ground. As B85 touches the ball A55 hits him causing the ball to become loose A30 recovers the ball at the B28 yard line. Ruling:
14. 4th a 15 from the A30, A8 punts the ball to receiver B81 who catches the ball runs toward his teammate B35, B81 hands the ball forward to B35 at the B37 yard line and B35 runs for a touchdown. During B35's run B55 blocked A90 below the waist at the 50. Ruling:
15. 1st and 10 from the A20, A8 hands the ball off to A23 who runs the ball to the A30. A75 held B90 at the A21 and wide out A88 cracked back and blocked B57 below the waist at the A24. Ruling:
16. 2nd and 3 from the A48, A8 hands the ball off to A23 who is tackled for a loss at the A46, during the run A75 held B57 at the A44. As the players are getting off the pile B90 spits on A23. Ruling:
17. 4th and 11 from the B41, A8 punts the ball to B15 at the B10 where B15 muffs the ball. A35 picks up the ball at the B8 and runs in for a touchdown. During the punt A35 was blocked out of bounds and returned inbounds as soon as he could. Ruling:
18. During a Free Kick from the A35, B22 muffs the ball at the A43, A15 blocks B54 at the A44 before A43 touches the ball, thus allowing A80 to pick the ball up and run for a touchdown. Ruling:
19. 3rd and Goal from the B3, A8 throws a pass into the end zone and A81 is held by B30 while the ball was in the air. Ruling:
20. #20. 4th and 4 from the B25, A12's field goal is good, B55 was legally blocked into holder A10 by A77, causing the holder to be roughed. Ruling:
