



Week # 7 10/15/05

1. A 4/10 B-20. After a successful field goal it is determined by the Umpire that the ball had a marking on it for use by the Kicker that was not approved by the Referee before the game. Ruling:
2. A 3/20 B-45. Before the snap the Umpire realizes that player B70 is wearing detachable 3/4" cleats. Ruling
3. The Umpire discovers that incoming substitute B60 is wearing protective equipment outside of his pants at the knee. Ruling:
4. During warm-ups the Umpire notices that team member A70 is chewing tobacco on the field. Ruling:
5. Between the 1st and 2nd period of an overtime game, player A11 is granted a requested time out. During the 2nd overtime period player A11 requests another time out. Ruling:
6. At the end of the period the Referee declares an officials time out for injured player B14. B14 remains in the game for the start of the next period after attending to his injury without causing delay of the next ready for play. Ruling:
7. A 3/15 B-30. Linebacker B55 is calling out defensive signals that simulate the sound of the offensive starting signals. The Umpire immediately throws his flag for a dead ball foul. Ruling:
8. A 3/G B-8. Prior to the snap, replaced player B77 leaves the field through the back of the end zone and proceeds toward his team sideline. The Side Judge immediately throws his flag for a dead ball foul. Ruling:
9. A 3/10 A-40. Runner A21 gains 5 yards and fumbles the ball. While the ball is loose the Umpire blows an inadvertent whistle and the ball is subsequently recovered by B11 at the A-49. Ruling:
10. A 4/8 B-40. During a scrimmage kick play the Punter A15 has to scramble after receiving a bad snap. The Punter A15 runs to the B-39 and punts the ball where it is immediately declared dead by the Line Judge. Ruling:
11. A 4/10 B-40. On a scrimmage kick play B11 gives a valid fair catch signal and touches the ball at the B-10. B14 recovers the ball at the B-5 where the ball is declared dead by the Back Judge. Ruling:

12. On a Free Kick play from the A-35 Kicker A20 asks teammate A40 to hold the ball due to strong winds. When the ball is kicked all A players except A20 and A40 are behind the ball. B17 catches the kick at the B-10 and advances it to the B-20 where he is down. Ruling:

13. On a Free Kick play from the A-35 Kicker A20 asks teammate A40 to hold the ball due to strong winds. When the ball is kicked there are 3 A players to the right side of A20 and 6 A players to the left side of A20. The Umpire throws a flag for illegal free kick formation and the ball is subsequently caught by B17 at the B-5 and advanced to the B-15 where it is declared dead. Ruling:

14. During a PAT play from the B-3 all offensive lineman are lined up interlocking their legs with one another and are in their final set position. The Umpire immediately throws his flag for a dead ball foul. Ruling:

15. On a PAT play from the B-3 the snap is fumbled by A-11 and recovered by A-15 who runs it into the end zone. Ruling:

16. A 3/8 A-30. Back A21 is positioned at the snap with the frame of his body completely outside the frame of the body of the normal tackle position. During the play A21 blocks B14 below the waist toward the original position of the ball 12 yards beyond the line of scrimmage and runner A24 is downed at the A-40. Ruling:

17. A 2/9 A-35. Runner A21 hurdles defender B11 at the A-40 and is subsequently downed at the A-42. Ruling:

18. On a Free Kick play from the A-35 Kicker A10 is blocked by B10 at the A-39 and the ball is subsequently caught by B15 at the B-20 and returned to the B-30. The Umpire throws a flag for the illegal block by B10. Ruling:

19. Runner A10 fumbles the handoff from A14 and while the ball is loose B74 pushes A70 in the back above the waist in an attempt to get to the loose ball. B74 subsequently recovers the loose ball at the B-40. Ruling:

20. PAT attempt from the B-3. B14 jumps on the back of lineman B70 during the kick in an attempt to block it. The kick is no good and the Umpire throws a penalty flag against B14.
