



Week # 8 10/22/05

1. Fourth and eight at the A-35. While the scrimmage kick is in the air B33 makes a valid signal for a fair catch at the B-22 then B28 muffs the kick at the B-18 and the ball rolls out of bounds at the B-9. While the ball was loose after the muff B33 blocks A45 at the B-20. Ruling:
2. Third and five at the B-45. A22 takes the hand off and runs to the B-39 where he runs into a pile of players. A79's helmet flies off from the contact and the covering official blows his whistle to stop play. Ruling:
3. Third and seven at the A-25. QB A10 scrambles toward the sideline, leaps at the A-24 and while airborne at the A-26 throws a forward pass toward eligible A87. While the ball is in flight B55 contacts A87 at the A-35. The pass falls incomplete at the A-37. Ruling:
4. Second and eight at the A-28. QB A10 recovers his tipped forward pass at the A-20, scrambles outside the pocket to avoid pressure and then in order to save loss of yardage he throws a pass from the A-25 out of bounds and beyond the neutral zone. Ruling:
5. Second and eleven at the A-3. QB A10's backward pass is batted in flight in the end zone by B99. While attempting to catch the ball A32 muffs the ball and it rolls over the goal line and out of bounds at the A-5. Ruling:
6. Third and six at the B-39. At the snap wide out A88 is pushed out of bounds by B28 and falls to the ground at the B-36. QB A10 drops back and throws a legal forward pass toward A88 who leaps from out of bounds at the B-34, catches the ball while in the air, and lands inbounds at the B-32 where he is tackled. Ruling:
7. Second and five at the B-10. Linemen A55 contacts B58 in the neutral zone and drives him to the B-7 where B58 drops back into pass coverage. A55 circles back behind the line of scrimmage to provide pass protection for QB A10 who then completes a pass to A88 in the end zone. Ruling:
8. Fourth and five on the A-35. Team A's punt untouched by Team B bounces at the B-5. A58 pushes B42 in the back above the waist to get to the ball and downs it at the B-2. Ruling:
9. Third and four on the B-45. A33 takes the hand off and runs to the B-48 where he is tackled. After the whistle B55 piles on. B75 was lined up in the neutral zone at the snap. Ruling:
10. Second and nine on the A-30. QB A10's pass bounces off the hands of eligible A88, strikes the Umpire, and is caught by A78 at the A-31. A78 runs and is tackled at the A-38. Ruling:

11. Fourth and eight at the B-18. Team A's field goal attempt is successful. After the kick B99 pushes A40 to the ground at the B-20 then taunts him. Ruling:

12. Third and twelve on the B-45. While QB A10 is scrambling looking for an open receiver, B98 holds A87 on the B-48. A10 is tackled at the A-49. Ruling:

13. Fourth and five on the B-18. Team A's field goal attempt is blocked at the B-19 and rolls to the B-4 where it is muffed by B-28 and goes out of bounds at the B-3. Ruling:

14. Fourth and goal on the B-6. A86 catches the legal forward pass and fumbles at the B-3. A75 recovers the loose ball in the end zone. QB A10 was roughed by B98. Ruling:

15. Fourth and goal on the B-8. Wideout A86 steps on the sideline at the B-7 to avoid contact from B58 then returns inbounds to catch the pass at the B-5 and fumbles at the B-2. B28 recovers the loose ball in the end zone and returns it to the B-7. Ruling:

16. Fourth and ten on the A-40. From a scrimmage kick formation punter A2 completes a forward pass to eligible A88 at the A-45. B29 contacted A88 at the line of scrimmage and continued the contact throughout the down. Ruling:

17. Second and eight on the B-38. A33 takes the handoff and runs to the B-32 where he fumbles. B55 intentionally bats the loose ball at the B-31 and it goes out of bounds at the B-29. Ruling:

18. Fourth and one on the B-24. QB A10 and A33 mishandle the handoff at the the B-26. The ball is simultaneously recovered by B98 and A78 at the B-22. Ruling:

19. Third and ten on the A-26. Runner A33 is tackled at the A-32. During the run grounded A78 intentionally trips B98 at the a-23. Ruling:

20. Fourth and four on the A-28. B23 receives the scrimmage kick at the B-30 and returns it to the B-37. During the return B55 is called for an incidental facemask against A43 at the B-32. Ruling:
