



Week # 9 10/29/05

1 Second and 10 at the A-6. A8 scrambles back into his end zone and throws a forward pass to eligible A25 who catches it and is tackled at A's 17-yard line. A70 holds B78 in the end zone. Ruling:

2 4th and 10 on the B30 and 4 seconds on the clock at the end of the half. A field goal attempt from the B37 is unsuccessful. On the play, A does not have 7 men on the LOS and B is offside. Time runs out in the half. Ruling:

3 3rd and 9 on the A14. Tailback runs off tackle to the A19. At the A16, the right tackle engages a defender high and just as he disengages the wing back blocks the same defender at the knee. Ruling:

4 2nd and 5 on the A5. QB throws a backward pass to the tailback who muffs the ball in the air in the end zone. B bats the ball in the air in the end zone and it goes out over the end line. Ruling:

5 4th and 5 on the B49. The receiver gives an invalid fair catch signal at the B15 and then muffs the punt at the B13. The ball rolls to the B5 where A recovers and runs for a TD. During the punt, B clipped at the B28. Ruling:

6 With the game clock running, Team A is in a scrimmage kick formation with fourth and eight at Team B's 35-yard line. The 25-second clock runs to 0:00. Team B declines the penalty for the delay-of-game foul. Ruling:

7 Fourth and six at Team B's eight yard line. A25 takes a handoff from quarterback A10 and then fumbles at the six-yard line. A25 recovers and scores a TD. Ruling:

8 Following Team A's touchdown run early in the third quarter, Team A players swarm into the end zone and are flagged for excessive celebration. Ruling:

9 At the snap A36 is positioned so that he is neither on the line nor in the backfield. He runs a down and out pattern and catches a legal forward pass for a 10-yard gain. Ruling:

10 Second and 10 at the A-6. A8 scrambles back into his end zone and throws a forward pass to eligible A25 who catches it and is tackled at A's 17 yard line. A70 hold b78 in the end zone. Ruling:

11 Second and seven at the A-35. After the running play is over inbounds at Team A's 40 yard line, B79 and A63 are flagged for fighting. B79 threw the first punch. Ruling:

12 Third down and two at the A 20. The game clock is running when Team A breaks the huddle. All players stop for one second except A18 who continues in motion away from his scrimmage line. A runs to the A25. Ruling:

13 A12 throws a legal forward pass to airborne A80 who receives the ball and while still in the air flips it backward. A34 muffs the ball which is then recovered by B17 who advances the ball and is tackled. Ruling:

14 B40 intercepts A18's forward pass at the B-7. His momentum carries him into the end zone where he is downed. Ruling:

15 First and 10 at the B-30. Runner A34 gains seven yards and is tackled at the B-23. The referee flags A78 for holding at the B-33. Ruling:

16 Third and seven from the A-34. A23 carries the ball to the A-38 and attempts to hand it forward to A78. A78 muffs the ball, it falls to the ground and is recovered and downed by a Team A player at the A-42. Ruling:

17 Eligible receiver A23 deliberately steps out of bounds and returns to the field of play during a play in which eligible receiver A89 catches a legal forward pass. A89 is tackled in bounds. Ruling:

18 Fourth and four at the A-40. B89 rushes the punter from his end position. A34, trying to protect the kicker, is slow getting to B89 and blocks him from behind above the waist, driving B89 into the kicker just after the ball has been kicked. Ruling:

19 B29 recovers A88's fumble at the B-4 and his momentum carries him into his end zone where he is downed. During B29's run, B65 clips A31 in B's end zone. Ruling:

20 B27 intercepts A's forward pass in B's end zone, unsuccessfully attempts to run it out, and finally steps over the end line. During B27's run, B43 holds at the B-8. Ruling:
